## WEDDING CONTRACT, TERMS & CONDITIONS, BOOKING FORM



The terms of this agreement form an integral part of this contract and are mutually agreed by both parties. Any variation or modification of this contract shall not be effective unless accepted in writing, by both Maria Barry and the client.

### BOOKING DEPOSIT

A deposit of £200 is required at the time of booking, together with a signed contract. Dates are reserved only when this deposit is paid. Please make cheques payable to Maria Barry Photographer. Credit card payments are accepted, please contact Maria Barry for details. The booking deposit is non-refundable.



### BALANCE PAYMENT

The balance payment is to be made not later than 28 days prior to the date of your wedding. Payment for additional prints for your album, is made after the wedding, at the time of ordering.

### FEES

The minimum total fee payable, of which your booking deposit is part, will depend upon the package required. We will issue an invoice for the balance payment 60 days prior to your wedding date. Additional prints for your album are priced at £20 each, regardless of size. Your wedding images will be placed on the website for viewing.



### CREATIVE LICENCE

Maria Barry shall be granted creative and artistic license in relation to the choice of locations and poses used. Maria Barry's judgement on photographic style and the number of photographs taken, shall be deemed correct. Due to changes in the weather, availability and the willingness of subjects, Maria Barry will do her best to honour requested photographs but cannot guarantee specific images, backgrounds, locations or group arrangements.



### VIEWING

A mutually convenient appointment for viewing photographic proofs will be made upon return from your honeymoon.

### COPYRIGHT

The 1998 Copyright, Designs and Patents Act gives full copyright to Maria Barry. You may not copy any photographs taken under this contract, allow copies to be made photographically, electronically or by any other means.

#### EXCLUSIVITY

Maria Barry shall be the sole professional (still) photographer at the venues specified. Family, friends and other guests are encouraged to take any photographs they wish to take throughout the day.

#### INSURANCE

In the unlikely event of total photographic failure, injury or sickness beyond Maria Barry's control, liability shall be limited to a full refund of all monies paid. Your statutory rights are not affected. Maria Barry has full Public Liability and Professional Indemnity Insurance.



#### CANCELLATION

If Maria Barry Photographer has to cancel this contract for reasons beyond her control, (death, injury, sickness, etc) liability shall be limited to a full refund of all monies paid

As compensation for loss of income for Maria Barry, the following charges will apply as a percentage of the total fee due.

(Number of days before the wedding date)

60 days or less - 100%

61-90 days - 75%,

91-120 days - 50%.



Should the cancelled wedding turn out to be a postponement, subject to Maria Barry's availability, all money paid may be applied to the new wedding date. In this case, the total fee chargeable shall be the fee which applies at the time.

In the event of Maria Barry taking another wedding booking for your cancelled wedding date a full, unconditional refund shall be made, except for the £200 booking deposit.
